This approval is subject to the following conditions:-


1. That the requisite land and infrastructure as per norms of ICAR and Other relevant regulatory statutory bodies shall be developed.
2. Prior approval of relevant statutory /regulating bodies shall be taken before starting of new courses
3. Due adherence to the guidelines issued by statutory/regulatory bodies as applicable in the respective programmes/courses will be ensured by the University before offering the programmes/courses from time to time.
4. University should ensure the approval of the respective regulatory bodies before starting General Nursing & Midwifery, B.Sc Nursing , P.B.B.Sc. (Nursing), M.Sc. (Nursing), Ph.D in Nursing courses .
5. Admission in the courses shall be given as per directions of Sate Government and relevant regulatory statutory bodies and provisions of University Act.
6. All other norms and conditions of the UGC, ICAR, National Medical Commission, Dental Council of India, Nursing Council of India and any other relevant regulatory statutory bodies shall be fulfilled.
7. The University shall immediately go for NAAC accreditation and obtain grade from NAAC and submit to the State Government within one year.
